4.4. EXPLICIT CONSENT FORM FOR THE PROCESSING OF PERSONAL DATA

In accordance with the Ministry of National Education Preschool Education and Primary Education Institutions Regulation, the Ministry of National Education Secondary Education Institutions Regulation and other legislation we request your explicit consent for the retention and processing of your personal data.

1. PURPOSE OF KEEPING AND PROCESSING PERSONAL DATA

In conjunction with the teaching, education and research activities conducted at high standards and in accordance with the current legislation, my personal data can be transferred through pre-registration and registration forms, commitment forms, hand-declaration forms, K12NET program, Türk Telekom Log Device, College Net Program, Miterya, physical locations and similar channels, depending on the nature of the service provided. I have been informed about what you have obtained verbally, in writing, visually or electronically by reading the Disclosure text on the Processing of Personal Data.

- My financial data such as my bank account number, credit card information, IBAN number, billing information,
- My school number,
- My prospective student information, my graduate information, my student information, my school awards, my school entrance grades, all kinds of exam result information, student transaction information.
- All my information regarding my student life, such as my knowledge, homework, social-artistic-sports activities, etc., which is kept for educational purposes,
- My professional information and family income information,
- My special personal data regarding religious beliefs, criminal convictions, clothing, health and security measures,
- In case of a visitor, my visitor information,
- My answers and comments that I share with the aim of evaluating your services,
- My closed-circuit camera system image and audio recording taken for inspection purposes,
- My personal data obtained when I contact you via e-mail, letter and other means,
- Navigational information, IP address, cookies, browser information obtained during the use of your website and mobile application, and medical documents, surveys, form information and location data that I submit with my own consent.
- My audio, image and video recordings to be used on the web page, social media pages such as Facebook, Instagram, YouTube channel, Tik Tok, Twitter and in written and visual media.

- Taking camera recordings to ensure in-school and environmental security,
- Planning and execution of institution-student relations management processes,

4. MY RIGHTS TOWARDS THE PROTECTION OF PERSONAL DATA

In accordance with the law and relevant legislation;

- Learning whether my personal data is being processed or not,
- Requesting information if my personal data has been processed,
- Accessing and requesting my personal health data,
- Learning the purpose of processing my personal data and whether they are used for their intended purpose,
- Knowing the third parties to whom my personal data is transferred at home or abroad,
- Requesting correction of my personal data if they are incomplete or incorrectly processed,
- Requesting the deletion or destruction of my personal data,
- In case my personal data has been processed incompletely or incorrectly, to request the correction of these and/or the deletion or destruction of my personal data to be notified to third parties to whom my personal data has been transferred,
- Object to the emergence of a result unfavorable to me by analyzing my processed data exclusively through automatic systems,
- I have been informed that I have the right to request compensation for the damage if I suffer damage due to the unlawful processing of my personal data.

5. SITUATIONS WHERE EXPLICIT CONSENT IS NOT REQUIRED IN THE PROCESSING OF PERSONAL DATA IN REQUIREMENT OF KVKK

- Data processing is mandatory for the establishment, exercise or protection of a right,
- In cases where data processing is mandatory for the legitimate interests of İlk Teori Eğitim A.Ş. provided that it does not harm the fundamental rights and freedom of the person concerned, İlk Teori Eğitim A.Ş. It may be processed by without seeking my explicit consent.

Data Security and Right of Application
